Interim Authorisation on Price for Fiji Sugar Corporation Bulk Pack Sugar and “Sugars of Fiji” Products in Fiji

Pursuant to sections 39 and 41 of the Fijian Competition and Consumer Commission Act 2010 and **the Fijian Competition and Consumer Commission (Price Control) (Supply of Sugar) (Ex-Factory) Order 2021**, the Commission hereby makes the following Authorisation.

Citation and commencement

1. This Authorisation is cited as Interim Authorisation on Prices for Fiji Sugar Corporation (FSC) Bulk Pack Sugar and “Sugars of Fiji” Products in Fiji and is effective from **20 July 2022 (Interim Authorization)**.
2. The prices set in Schedule 1 are the maximum ex-factory wholesale prices for sugar. The said prices shall apply throughout Fiji, unless determined otherwise by the Commission.

Conditions to this Interim Authorisation

3. The following conditions apply for this Final Authorisation.
 - a. The FSC is to ensure that, should they sell the Bulk Pack Sugar 50kg bag in Fiji, they must price the 50kg bulk pack sugar at the proportionately increased at twice the price of the authorised 25kg bag price as set out in Table 1. For the avoidance of doubt, if the maximum price for 25kg is \$57.50 (VEP), the price of 50kg shall be \$115.00 (VEP).
 - b. Where the product, Sugars of Fiji listed in Schedule 1 of this Authorisation will also be sold in re-wholesale quantities, the buyer will need to make an application and seek price Authorisation from the Commission.
 - c. Where the maximum price of an item listed in Schedule 1 is required to be rounded off to the nearest whole number, it should be done on the total prices rather than on individual unit(s).
 - d. This Authorisation must be displayed at a prominent place within FSC’s premises and websites at all times.
 - e. The Commission will closely monitor the market to ensure that the items specified in Schedule 1 is always made available in the market.

- f. The FSC is to provide management level data disclosure to FCCC on monthly basis and disclosure of draft financials by 30 June 2023.
- g. The FCCC will monitor FSC expenditure and assess mediums utilised by FSC to control current operational expenditures.

Validity

- i. This Interim Authorisation supersedes all previous authorisations, agreements, or understandings in connection with its subject matter.
- j. This Interim Authorisation shall remain in force until **20 January 2023**, unless earlier revoked, amended, or varied by FCCC.
- k. No new price pertaining to the supply of Bulk Pack Sugar and Sugars of Fiji Products in Fiji by FSC shall be levied, applied, or charged unless authorised by the Fijian Competition and Consumer Commission.
